Policy Division

I. Rules & Guidelines

- C. Searching for additional evidence on the internet while the debate round is in session is not allowed and will count as cheating.
- D. Speed-talking through a speech is not allowed and speaker points will be taken off for doing so. Please speak at an intelligible pace for the judges and the opponents to be able to understand the contents of the speech.
- E. There will be one judge per preliminary round and a panel of three judges for each elimination round, including the final round.
- F. Please be respectful to other debaters and your judge. If any participants feel that they have been disrespected or bullied, please bring up your concerns to the tournament organizers.
- G. Debaters will be awarded speaker awards and finalist awards on top of participation awards so please don't be discouraged if your team loses some debate rounds.

II. Format

A. Speeches

- 1. Each team has 2 constructive speeches and 2 rebuttal speeches. The speaking order for Policy debate is as follows:
